With so many needs right here at home, why do we sent our money overseas?

All you want to talk about is money!

Fellow Rotarians, these are some comments that come when we ask for a commitment to The Rotary Foundation. They come with the territory and certainly with some merit. We do give at the office and to our church or synagogue, and to the Red Cross and to the high school band going to the Rose Bowl Parade. We give to many things and we give to The Rotary Foundation. Each of our Rotary Clubs is involved in determining the needs of our community and then addressing them. We want to serve our community – one of our Avenues of Service is Community. The Board of Trustees of The Rotary Foundation heard this concern several years ago and created a program called District Simplified Grants. This is administered locally with the available funds. Each club can submit their request to the District Foundation Committee for matching funds – in our case to Vasanth Prabhu. Each year for the past several years we have not used all the available District Simplified Grant funds.

As for the talk about money – yes we do, but that is not all we do. We always relate the dollars to lives that our changed. Lives like the children who will not contract polio because they received an inoculation against the disease.

Lives like those in Tanzania who now have a well to obtain potable water instead of the four hour walk to get one jug of contaminated water. Lives like those in Sierra Leone, Liberia, Guinea, and Côte d'Ivoire where the peace caravan passes to promote harmony along the borders. Lives like those in Israel, Italy, or India who came to District 7450 over the past few years as part of a Group Study Exchange to learn about another culture and returned with many new friends.

Yes Rotarians, we do ask for money because it can help keep our hopes high for peace. It can provide the tools and teachers that bring about literacy and it can provide the hygiene products as well as the understanding of how to use them to improve the lives of women and children around the world.

As we evaluate how we can spend and invest our treasure, I ask if there is a way that can impact more people in more different ways that The Rotary Foundation. We ask for an average of \$100 per Rotarian per year. That's less than the cost of a nice dinner for two. Consider where you are and make a contribution as you can. Challenge yourself. Rotary Scholarships in a Nutshell

Ambassador Scholarships

When to apply annually:

---April 1 to May 1....Applications due at the Rotary Club where the candidate resides; local Rotary Club checks for completeness, interviews applicant, and if approved, endorses candidate... one recommendation per club is allowed.

---May 1 to June 15District 7450 Scholarship Committee reviews applications from local Rotary clubs and selects winner (s) to be submitted to Rotary Foundation for final approval which usually occurs by November. Study begins in the fall semester of the following year.

---Amount of Award & Number of Scholarships is determined annually by District 7450 (currently a flat grant of \$26,000 for one scholarship) for study abroad.

Requirements: Humanitarian focus for the future. At least two years of college; record of academic achievement and leadership prowess; willingness to act as an ambassador of good will and visit Rotary Clubs in the country of study. (Many past winners have had three years of college when they applied and then used the Ambassador Scholarship for the 1st year of master's degree study.)

Peace Fellowships Master's Degree

When to apply annually:

-----April 1 to May 1....Applications due at the Rotary Club where the candidate resides; local Rotary Club checks for completeness, interviews applicant, and if approved, endorses candidate...unlimited recommendations per club are allowed.

---May 1 to June 15District 7450 Scholarship Committee reviews recommended candidates from local Rotary clubs and selects applicant to be submitted to the Rotary Foundation which determines the winners usually by December.

Study begins in the next fall semester.

Amount of Award: Fully funded tuition, boarding, transportation and miscellaneous expenses at one of four designated universities abroad for two years. The four university choices available to United States applicants are the International Christian University in Tokyo, Japan; the Universidad del Salvador in Buenos Aires, Argentina; the University of Bradford in West Yorkshire, UK; and, the University of Queensland in Brisbane, Australia.

Requirements: Undergraduate degree; proficiency in a 2nd language; three years of full time work experience; academic prowess; commitment to a career in peace and conflict resolution.

Peace Fellowship Certificate

This program is for three months for study at Chulalongkorn University in Bangkok. Past winners have come from a wide variety of professional backgrounds.

Employers of candidates asked to contribute but all candidates are considered for a fully paid fellowship (tuition, boarding and transportation) for the three months of study.

The application window is:

---April 1 to May 1....Applications due at the Rotary Club where the candidate resides; local Rotary Club checks for completeness, interviews applicant, and if approved, endorses candidate...unlimited recommendations per club are allowed.

---May 1 to June 15District 7450 Scholarship Committee reviews applications and selects recommended candidate to be submitted to the Rotary Foundation which selects the winners for three months of study in either January or July of the next year.

Requirements: Currently employed full time; Undergraduate degree; five years of work experience; demonstrated commitment to working toward peace and conflict resolution.

Community Health Advocacy Program (CHAP) International Matching Grants

“Two of the three phases of the **Community Health Advocacy Program CHAP**) were completed in Kochi, Kerala State, India from October 2007 to September 2010” said by Dr. Govinda Malya, the project director and past president of the Westtown-Goshen Rotary Club. CHAP is an international Matching Grant project jointly undertaken by the Westtown-Goshen Rotary Club, Westtown, PA, District 7450 USA (the international partner), and the Rotary Club of Fort Cochin, Kochi, District 3200 India (the host partner). CHAP is a 4-year pilot program to develop a “prototype model” and to provide FREE health care to economically disadvantaged, orphans, the old and the disabled people in Kochi, India. The program entails screening, treatment, follow-up visits and health education for diabetes, hypertension and asthma/COPD using mobile van to deliver the health care services to these people who otherwise would not have access due to remote areas they live. The “protopype” will be used in other countries, viz., Kenya and Peru.

Dr. Malya commented “Mr. R. R. Bhat, project coordinator and past president of the Rotary Club of Fort Cochin, Kochi, India, was instrumental to conduct the program with support fom Rotarians, area hospitals, volunteers and NGOs to strengthen community service and to ‘Sharing Rotary’ with the general public and to improve public image of Rotary”.

During the two matching grants (Phase 1 and Phase 2), 3,712 patient visits and 55 screenings were completed in three strategic areas and 7 sub-locations, within 3 miles radius in Mattahcnerry, Kochi, Kerala State, India. The patients were provided free of charge health checks, medicines and health education on diabetes, hypertension and asthma/COPD. The patient demographics were 37% males, 63% females and <1.0% children of age ranging from 7 to 79 years. This, also, represented 47% of patients who re-visited more than once since these patients were positively diagnosed for diabetes, hypertension and/or asthma/COPD. Medication was provided free of cost to the duly diagnosed patients and also, education related to the diseases were also, provided to these people through mass awareness, one-on-one interaction as well as in class room panel settings.



The disease distribution in patients with positive diagnosis during first visit and subsequent visits were 22% diabetics, 21% hypertensives, 7% as-matics/COPDs and combiation of these diseases. Significant decreases in blood sugar (fasting blood sugar or post parential blood sugar) and reduction in distolic and diastolic blood pressure revealed that the program has been making an impact on Below Poverty Level people in Kochi, India.

Overall, the program not only increased awareness of these chronic disease conditions, but also it has provided baseline measurements in the BPL population which the population would not have ever received. Furthermore, it will improve their “quality of life”.

The Phase 3 of CHAP will be undertaken in the near future to continue to develop the “prototype” and eventually to replicate it in other countries.

The program will have long term benefit helping a society to better the peoples' health and educate them about their health. Overall it will improve their quality of life.

David Gau was the unanimous selection of the Rotary District 7450 Committee as the recipient an Ambassador Scholarship to study in 2011-12. David was sponsored by the Rotary Club of Kennett Square. Rotary International has already approved the District 7450 recommendation of this candidate. He will attend the University of New England in Armidale, Australia for graduate study in 2011-2012.

David has excelled academically as an undergraduate at the University of Pittsburgh with a "triple major" in bioengineering, mathematics and economics. He will commence his senior year at Pitt in the fall of in 2010. He has coupled his scholarly achievements with a solid record of campus leadership and community service.

Bob Lankin Named to Serve as the Next District Rotary Foundation Committee Chair



Bob Lankin, founder and current President of the Rotary Club of Northeast Sunrisers, Philadelphia Pa., has been named as the next Chairperson of the District Rotary Foundation committee, by District Governor Elect, Bonnie Korengel. His term will begin on July 1, 2011.

Lankin has served as a Rotary Foundation committee member for numerous years prior to and after his term as District Governor in the 2005-06 Rotary year. During his year as governor, the district greatly improved attendance at District training functions, including the Mid-Atlantic PETS, Assistant Governor and Committee training, Rotary Foundation and Membership Development workshops and with the District Assembly which hosted a high point of 220 Rotarians. Over 265 Rotarians and guests participated in the District conference which was held at the Racquet Club in downtown Philadelphia. Lankin initiated the first Pre-PETS in our District and conducted a successful Mid-Year Assembly. During his year, the Katrina disaster took place and as the District governor, he established a special Gundaker fund which raised over \$58,000 and was utilized to assist non-profit organizations in Biloxie Mississippi.

Since serving as Governor, Lankin has served as the District Chair of the Rotary Leadership institute, as District membership Chair, as a training team member, and as the Chairperson of the district nominating committee. He also played a role in the drafting of the new District Corporation by-laws. In his 22 years as a member, he has recruited over fifty people to become members of a Rotary Club including ten people who eventually served as club presidents.

Bob and his wife Holly are major donors to the Rotary Foundation and are members of the Paul Harris and Bequest Societies. He is the Branch Manager of Raymond James Financial Services Inc., in the Glenside and Quakertown offices. He is an Attorney, a Certified Financial Planner and a Certified Estate Planner.

Lankin looks forward to his role leading our district committee, encouraging greater participation in the programs of the Rotary Foundation, and to establishing a new program encouraging greater contributions to our foundation.

Rotary Peace Fellowship Winner Feted at Meeting of the Rotary Club of Philadelphia by Joe Batory

Lieutenant D F Pace, a distinguished member of the Philadelphia Police Department, was publicly acknowledged as a winner of a Rotary International Peace Fellowship at the weekly meeting of the Rotary Club of Philadelphia on Thursday, December 2, at the Union League in center city Philadelphia.

A packed room of attendees included the Philadelphia Commissioner of Police (The Philadelphia Police Department is the 4th largest in the USA), four other high ranking Philadelphia police officers, Rotary District 7450's District Governor Joan Batory, District Governor Elect Bonnie Korengel, District Governor Nominee Dave Ellis and Past District 7450 Governors Tom McCarthy, Lynmar Brock, and Hogie Hansen.

Three Philadelphia Television stations covered the event.

This Rotary scholarship is for three months of study at the prestigious Chulalongkorn University in Bangkok, Thailand. Lieutenant Pace will attend the session that begins in June of 2011. The curriculum focus is on violence prevention, mediation, compromise building and the philosophy of peace building. Born in Italy and raised in the humble surroundings of an immigrant family, Lieutenant Pace exemplifies the finest qualities of a law enforcement officer. He is "self made" with a proven work ethic. Indeed, he is one of only five lawyers among Philadelphia's 6600 police officers. Lieutenant Pace has extensive patrol experience in the field and he is also a valued instructor in the Philadelphia Police Academy. In his teaching, he echoes the vision of Philadelphia's Police Commissioner Charles Ramsey toward creating a new generation of police officers with enhanced professionalism, dramatically improved judgment skills, and a true dedication to being instruments of peace.

At Thursday's Rotary meeting, Commissioner Ramsey praised Rotary for its Peace Fellowship initiatives and promised that Lieutenant Pace would fully use this scholarship study to influence other police officers upon his return from Bangkok.

Lieutenant Pace expressed his deepest gratitude to Rotary and emphasized his full commitment to maximizing the learning experiences he will obtain at Chulalongkorn University.

Philadelphia Rotary president Joe Batory offered this summary: *"I cannot emphasize strongly enough that this is a world class competition and that winning a Peace Fellowship is a monumental accomplishment. Lieutenant Pace is now among a distinguished group of Rotary Peace Fellows which has representatives from 44 countries with an average age of 32 and with an average of seven years of experience. And Rotary International has termed this year's winners as "a very promising array of peace builders ever from all across the globe."*

"We in the Rotary Club of Philadelphia, and in Rotary District 7450, and now in Rotary International firmly believe that Lieutenant Pace is clearly in the perfect position to have a major impact on the next generation of Philadelphia police officers using the skills and knowledge and international perspectives he will obtain from study at Chulalongkorn University. There could not be a better use for this type of Rotary Peace Fellowship."

"It is wonderful indeed for our local Rotary clubs (Rotary District 7450) to have a winner from this international competition for the Peace Fellowships. But much more importantly, we in Rotary are convinced that Lieutenant Pace is a superb representative of the Philadelphia Police Department with the intellectual commitment, the philosophical base and the professional ability to use this Rotary Peace Fellowship to make a significant impact for the better in the city of Philadelphia."
