Two Rotary International Peace Fellowship Winners Announced

Philadelphia Assistant District Attorney Erin Boyle and Philadelphia Police Lieutenant LaMonte Adams were recently named as winners of the prestigious Rotary International Peace Fellowships for 2014. They were honored at a Rotary Club of Philadelphia luncheon meeting on November 21st at the Union League.

The Peace Fellowship for each recipient is for a fully-subsidized study at the Rotary Peace Center at Chulalongkorn University in Bangkok, Thailand (The “Harvard of the East”). The curriculum focuses on “state of the art” and practical approaches to violence prevention, compromise, mediation and peace building. The peace program will run from January 8th to March 28th, 2014.

Peace Fellowship Winners – Bonnie Korengel, District 7450 Foundation Committee Chair, congratulates Peace Fellowship winners Erin Boyle, Philadelphia Assistant District Attorney, and LaMonte Adams, Philadelphia Police Department Lieutenant, at a recent meeting of the Philadelphia Rotary Club.



Having two Philadelphia winners for this three-month study experience abroad is unprecedented. In fact, the two Philadelphia winners are among only 35 Peace Fellowship winners in the world who were selected for this honor. This achievement was the culmination of a rigorous and yearlong process coordinated by the District 7450 Scholarship Committee, chaired by Joseph Batory, who coached and steered the two candidates through this demanding international competition.

“Erin and LaMonte are outstanding individuals who already have many significant accomplishments in their law enforcement careers here in the city.” said Batory. “They will truly benefit from studying with other world class scholars in Bangkok and eventually bring home lots of practical ideas to share with their colleagues here in Philadelphia.”

Erin and LaMonte will be available to speak about their Peace Fellowship experience after they return next spring.

GRANT MANAGEMENT TRAINING

The New Grant Model requires strict stewardship of grant money, and this requires the Primary Contact handling a project to be certified in recognition of their training. Three training seminars have been held in November at various locations.

Global Grants now replace what were called Matching Grants, and now range from \$30,000 to \$200,000. Global Grants cover Humanitarian Projects, Scholarships for graduate-level academic studies, and Vocational Training Teams. Of course, these grants must align with the six areas of focus, respond to real community needs, be sustainable, include measurable goals, and meet the objective of Rotary to promote world understanding and peace.

Global Grants are funded by cash contributions of the club - matched \$0.50/\$1 by the World Fund, and District contributions - matched \$1/\$1 by the World Fund. The minimum project size is \$30,000.

Scholarships are \$30,000, and are funded \$1/\$1 by the World Fund.

Peace Fellowship candidates are endorsed by the District and totally funded by the World Fund of The Rotary Foundation.

This year, 30% of the District funds have been allocated for District projects. Cash contributions of the club are matched by the District. funds allocated by the District for these projects must be submitted as a budget to The Rotary Foundation prior to the project year. Therefore, the clubs must submit their proposal prior to the year it will be performed.

MINIMIZING TAXES ON HIGHLY APPRECIATED ASSETS AND DONATING TO THE ROTARY FOUNDATION

As you wrap up your 2013 tax year you might be discussing with your tax advisor and family a donation to the Annual Fund or to the Endowment Fund because you've seen many of your non-qualified stock holdings significantly increase. You benefit in three ways: (1) you get a tax deduction, and (2) you remove interest, dividends, and/or capital gains from your investment portfolio (3) you're donating to your favorite charity-Rotary. Here is an idea of why to give appreciated stock versus cash.

Lucy (assuming 25% or higher tax bracket) wants to make a charitable gift of \$10,000. She can make her gift with either cash or stock. Let's assume that Lucy has XYZ stock currently valued at \$10,000 which she bought for \$4,000 (her cost basis). If she were to sell the stock she has to realize a \$6,000 long-term (LT) capital gain (held longer than 12 months) that is taxable in 2013. If Lucy directly donates the appreciated stock, this LT gains tax is eliminated, saving her \$900 in taxes ($\$6,000 \times 15\%$ LT tax rate=\$900). Additionally, Lucy will realize a charitable income tax deduction of the \$10,000 if she itemizes her deductions on her federal income tax return.



POLIO ERADICATION UPDATE FOR YEAR-END 2013

As 2013 draws to a close, it is important to note and be encouraged by the progress that we Rotarians – along with the global community - have made in wiping out the dreaded polio disease; and of course, we must also be realistic about the challenges we face and the need to keep pursuing the end goal – the total eradication of polio from the face of the earth.

First the good news:

- In Afghanistan, no indigenous cases of wild poliovirus have occurred all year - all cases are linked to cross-border transmission with neighboring Pakistan.
- In Nigeria, the polio virus is increasingly geographically restricted - primarily to Kano and Borno states. Over the past 4 months, only four cases have occurred in the country, despite the onset of the rainy season (the “high season” for polio transmission).
- The Horn of Africa outbreak is on the decline, including in Banadir, Somalia, the “engine” of the outbreak (no cases since July).
- A cross-regional emergency approach is being implemented in the Middle East where more than 20 million children will be immunized because of the recent infections in Syria. Dr. Bruce Aylward of the W.H.O. assures us that all children passing through refugee camps will be immunized.
- The overriding operational priority for the Global Polio Eradication Initiative is to ensure all children are reached during supplementary immunization activities during the 2014 ‘low season’ for polio transmission.

And now for the challenges:

- In Pakistan, the primary problems reside in the Federally Administered Tribal Areas (FATA), in particular North Waziristan. During the ‘high season’ in the past four months, 52 cases of wild poliovirus have been reported from FATA, with evidence of widespread geographic transmission across the country. Areas within Pakistan are being re-infected, as is neighboring Afghanistan, and the outbreak in the Middle East originated in Pakistan. North Waziristan is the area with the largest number of children being paralyzed by poliovirus in Pakistan. Immunization activities have been suspended by local leaders since June 2012. It is critical that children in all areas are vaccinated and protected from poliovirus. Immunizations in neighboring high-risk areas are being intensified, to further boost population immunity levels in those areas and prevent further spread of this outbreak.

This time last year we had only 214 polio infections globally. To date this year we are at 360. Only 136 of those 360 cases were in endemic countries, Nigeria, Pakistan and Afghanistan. The remaining 224 cases were from non-endemic countries, primarily Somalia where 183 children were infected. So one can see that political unrest and instability represent major roadblocks to eradication of the disease, but Dr. Aylward of the W.H.O. remains optimistic about our ability to overcome these obstacles. After all, if India can obtain and retain polio-free status, we can make it happen everywhere!
