VOCATIONAL TRAINING TEAMS

Vocational Training Teams (VTTs) offer a hands-on approach to vocational service. VTTs are groups of professionals that travel internationally to learn more about their own vocation or to teach other professionals about a particular field. A VTT helps create sustainable changes by strengthening the knowledge and skills of individuals and communities; thereby improving their ability to serve. Rotarians participating in a vocational training team have the opportunity to make an impact long after their travel ends.

The Rotary Foundation's District, Global and Packaged grants all support VTTs; however, each grant type has different requirements. Clubs that are interested in applying for VTT grants are required to submit the Vocational Training Team Grant Proposal (Form attached) by April 30, 2014 for the Rotary Year 2014-2015.

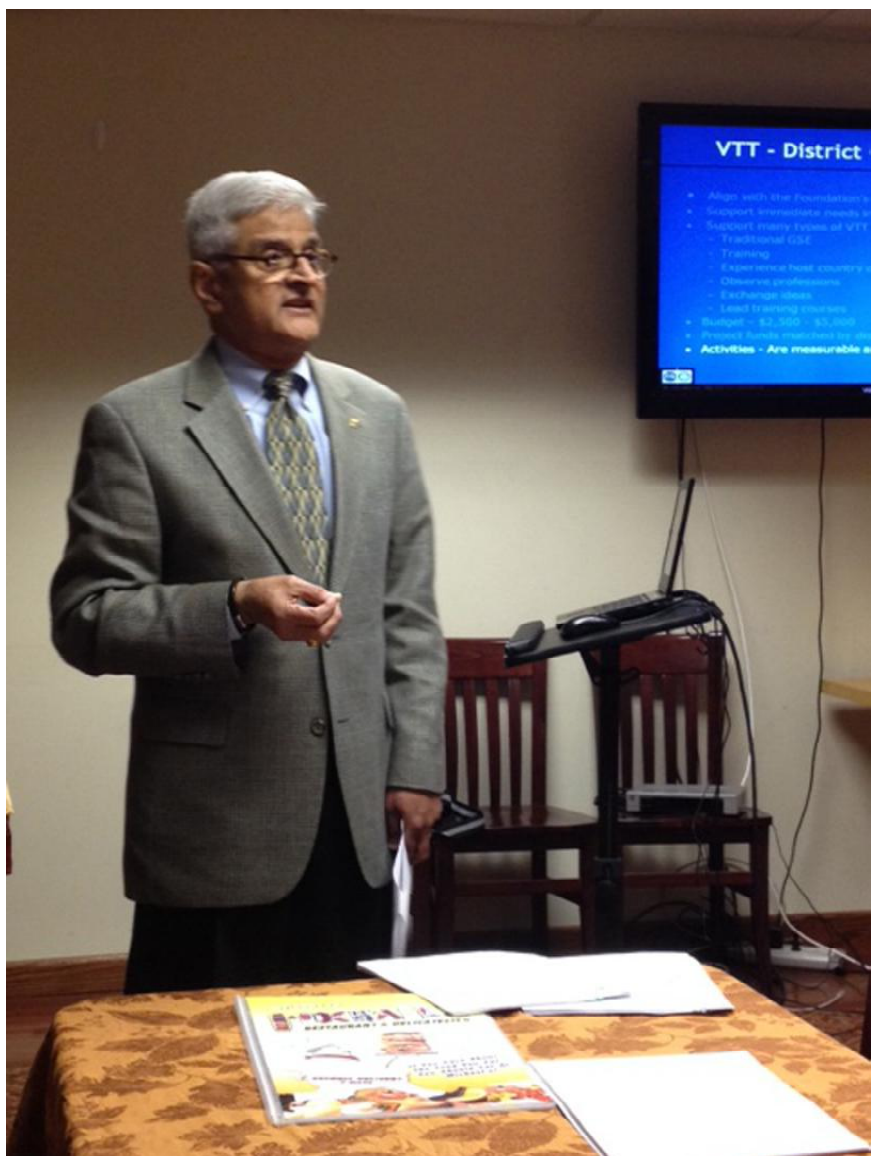

Perhaps the easiest, and most significant, way to support Rotary is to include a commitment in your estate plan. Individuals and couples can make provisions within a will or trust, name Rotary as the beneficiary of an insurance policy or retirement plan, and transfer ownership of a bank or investment account automatically after death. Rotary recognizes such generous planning with the following:

Benefactor: Individuals who have made Rotary's Endowment Fund a beneficiary in their estate plans, or who have made an outright gift of \$1,000 or more to the Endowment Fund.

Bequest Society: Individuals and couples who commit not less than \$10,000 in an estate plan to The Rotary Foundation.

Rotary's goal is to raise \$1 billion in net assets and gift commitments by 2017 — the 100-year anniversary of The Rotary Foundation. No doubt everyone has their own personal reason; but the objective of Rotary International, to promote world understanding and peace, should not be forgotten; and certainly the Four Way Test should guide us in dealing with others. If the Objectives and Four Way Test are forgotten; then we do not have a Rotary Club, and we are the losers as we do not grow as human beings.



As a Rotarian, Are You Weary of Fund-Raising for Polio?

Well, read on to learn some very interesting facts about why we can't stop now, even though we've been at it for more than 25 years.

- Because “we’re this close” and the strategic endgame plan for polio eradication calls for polio to be gone by 2018, but 2014 is going to be a critical year for fund-raising.
- Because to make this \$5.5B endgame plan work we have to help raise the \$1.5B shortfall that is still required to end polio.
- Because we have the tools and the systems to eradicate polio – as we did in India in January 2014 when the country was declared polio-free after 3 years of no polio cases. If we can do it in India with billions of children, we can do it anywhere.
- Because we are developing new techniques like border immunization stations for highly mobile populations to make sure that all children, even those on the move, are protected. And certifications of immunization are now being required at many border crossings.
- Because we have achieved great success, even in Nigeria and Afghanistan where the number of polio cases was down 40% in 2013 from the previous year.
- Because for every \$1 your club raises, the Gates Foundation will match with \$2. So your efforts really can yield results!
- Because Rotary has already donated \$1.2B to the cause and we have pledged to finish the job.
- Because if we don't, more than 200,000 children could be infected by 2022.
- Because there are still many people in our communities who are willing to help but we have to lead the way.
- **Because we promised the children of the world!**



So, put on your “End Polio Now” pin, talk up polio eradication at your next club meeting (maybe even share some of this information) and decide how your club is going to help kick Polio off the face of the earth by involving your community.
