



District 7230 Governor 2005-2006

Helen Reisler has been a dedicated Rotarian since 1988 when she became the first woman member of The Rotary Club of New York. She chaired a variety of committees including Community Service, Environment, Advertising, and Public Relations. Her creation of the Gift of Life "Host Committee" inspired 30 active participants and attracted a \$75,000 grant. She has interviewed Ambassadorial Scholar applicants for 10 years, has counseled three incoming scholars, served as a Board Director for twelve years, and is a Trustee of her club's Foundation.



"New York Rotary – A Club That Works" and "Gift of Life – A Child's Story," a series of videotapes and a documentary

produced by Helen, have both been shown on Manhattan Cable TV. Her efforts to highlight interesting club members resulted in their appearances on "The Today Show" and Channel 4 "A Good Cause." RI President Lacy appointed Helen the Media Liaison for the New York area.

Helen's involvement in District #7230 activities has included Foundation Trustee, Exhibit Coordinator and Media Room Coordinator at various District Conferences, Gift of Life Committee member, contributor to District newsletters and advisor to the Rotaract and Interact clubs.

In 2001 Helen became the first woman President in the 92 year history of the Rotary Club of New York and was unexpectedly faced with the greatest challenge -- the 9/11 terror attack on NYC. Her focused leadership kept up her club's spirit and helped to raise \$1.4 million which was efficiently disbursed to the neediest. She and her team arranged vacations for 45 rescue workers and inspired the article "Ground Zero" in the December 2001 Rotarian Magazine, as well as newspaper coverage. She also spoke at District Conferences around the nation, at the request of other Rotary Clubs. The June, 2005, "100 Years" edition of the Rotarian Magazine also featured these accomplishments.

Helen was awarded a Paul Harris Fellow by her club in 2003, a "Service Above Self" plaque in 1997 and Appreciation Trophy in 2002. She has received multiple District citations for Public Relations, the Bronze "Distinguished President" pin from RI, Certificate of Appreciation from Mayor Dinkins, Citation of Merit from Bronx Borough President Ferrar, a Certificate of Appreciation from the Polio Eradication Initiative, and the 1905 Silver Nickel award for setting historical precedents in Rotary. She was elected to the Rotary Global History Fellowship Board of Directors and appointed Chair of the Fellowship Committee.

Helen has a B.S. from New York University and a M.S. from Long Island University. She taught in the new York City school system, was an adjunct lecturer at L.I.U. Graduate School, Vice-President of the New York Yellow Pages –Manhattan Bluebooks, New York Manager of Recruitment and Public Relations for Southwestern Bell, and moderator of "The New York Business Forum" on Manhattan Cable TV. She was named "Partner in Education" for creating high school internships in the business arena, was a director of the Sales and Marketing Executives and a founder of the "Sales Hall of Fame."

Helen is presently a Consultant in Public Relations, a Director of the Park Slope Geriatric Day Care Board, the "100 Club" Board, and her condo Board in Westchester. Her bio is highlighted in several Marquis "Who's Who" books. She has three children and six grandchildren. Helen's husband, Mel, an attorney was a Paul Harris Fellow.

Douglas R. Blazey joined the Rotary Club of Wayne in 1998. He became Secretary and served as President during Rotary years 2002/2003 and more recently in 2012/2013. Doug has continuously served on the Wayne Board of Directors. Doug completed Rotary Leadership Institute training through the graduate level and is a member of the Rotary Leadership Institute faculty.

Governor Doug led the Group Study Exchange Team to Queensland, Australia in 2004, served on the District's Group Study Exchange Committee, and became the District International Service Committee Chair. Doug mentored an Ambassado-

rial Scholar—a role he enjoyed very much, actively supports RYLA, and for many years interviewed candidates at Radnor High School for the annual Wayne Rotary scholarship.

Doug also serves our District 7450 Gundaker Rotary Foundation: he was the Annual Giving Chair for 2011/2012, on the District Board of Directors during 2011, and is on the District By-Laws Committee.

Doug Blazey is an attorney by profession, specializing throughout his career in environmental law. A graduate of Yale Law School, Doug served in the Pennsylvania Department of Environmental Resources from 1970, which he helped to establish, and was Chief Counsel there for a number of years. In 1984, Doug became Regional Counsel for the United States Environmental Protection Agency in New York City as one of ten Regional Counsels in the US. Serving under both political administrations, Doug was recruited to private practice in 1995 with Elliott Greenleaf & Siedzikowski, P.C. headquartered in Blue Bell, Pennsylvania. Doug is a frequent lecturer to attorneys through Continuing Legal Education.

Before entering the practice of law, Doug taught disadvantaged youth at Trenton High School. His commitment to teaching our youth continued, as he served as an Adjunct Professor of Law at the New York Law School and is an Adjunct Professor on the Temple's Fox School of Business Law faculty.

Doug and his wife Julianna are members of the Rotary Club of Wayne. Their daughter Elizabeth received her Bachelor's and Master's Degrees from the Georgetown University School of Foreign Service, and is working as a financial investment analyst with JP Morgan in New York City. Their son Christopher, who also graduated from Radnor High School, is an Eagle Scout and an AP Scholar, and attends the Georgetown University School of Foreign Service. Christopher carried the Wayne banner in the Independence Day Parade with Rotarians in Philadelphia and participates in many Rotary activities, and is a member of the Rotary Club of Central Delaware County.

Doug Blazey, his wife Julianna, and their children Elizabeth and Christopher are all Paul Harris Fellows.

Chad Rosenberg



District 7450 Governor Elect 2015-2016

Chad Rosenberg has been a Rotarian since 2001; however, his first exposure to Rotary occurred in the 1970's when Chad attended Philadelphia Rotary Club meetings with his Father, Harry, at the Bellevue Stratford Hotel. At that time the Philadelphia Rotary Club was the third largest in the world with over 700 members.

In the summer of 1980, at age 15, Chad participated in a short term exchange to Finland that began is life-long love of the Youth Exchange program. He joined the District Youth Exchange Committee in 2007, and in 2013 the circle was completed when his son Milo participated in a long-term exchange to Germany. To date, Chad and his wife have been the host parents for three foreign students from France, Sweden, and Ecuador.

In 2006 Chad started the Harry C. Rosenberg Youth Exchange Scholarship. Named after his father, this needbased scholarship helps students, who could not otherwise afford it, to participate in the Rotary Youth Exchange Program. To date over \$70,000 has been raised from the Aim for Exchange Sporting Clays tournament that is held annually in October. As a result, over \$45,000 in scholarships has been awarded to deserving students from the Delaware Valley.

Chad served as President of the Bala Cynwyd - Narberth Rotary Club for two and a half years from 2004 to 2006 and as the Chair of the District 7450 Public Relations & Communications Committee from 2013 to 2015.

In November of 2011 after a visit to Longwood Rotary Club, Chad was inspired to start a new Rotary Club. On June 14, 2012 the Rotary Club of the Upper Main Line was officially chartered with 32 members. Chad served as the Charter President for two and a half years until 2014.

In his professional life, Chad is a Principal of Rosenberg & Parker, a 68-year-old international, boutique surety bond broker with offices in King of Prussia Pennsylvania, Toronto, and Istanbul. His clients include large commercial construction firms as well as Fortune 500 sized multi-national corporations.

Chad is the father of five children ranging in age from 9 to 24. He lives with his wife Jennifer in Berwyn, Pennsylvania.

Arava Institute – Hershel Richman

Hershel Richman is an experienced litigator, counselor and negotiator who, over his 30+ year career, has represented and assisted clients in the intricacies of environmental and land use law, and the development of strategies to expedite permits, to coordinate multi-governmental agency reviews and to avoid or minimize the risks of litigation. Hershel joined the Friends of the Arava Institute Board of Trustees in 2011 and has served on the board's Executive Committee since that time.

The Arava Institute's mission is to create a world-class environmental teaching and research institute that prepares young leaders to cooperatively solve the region's environmental challenges; maintains high academic standards; delivers teaching and trans-boundary research opportunities at the highest quality and level to students from the Middle East and from all over the world; plays a leading role in research conservation, environmental protection and sustainable development in the region; and generates the regional capacity for conciliation and cooperation in the Middle East, in order to transcend political boundaries and achieve environmental change.

Business Fights Poverty – Tim Prewitt

Join us as Tim Prewitt, CEO of International Development Enterprises (iDE), discusses the importance of reaching scale in water and sanitation. How can we leverage the power of business to reach scale? What does it take? What should we expect from our efforts to bring clean water and healthy sanitation to the developing world? And why do almost a billion people live without clean water and adequate sanitation anyway?

Mr. Prewitt will provide examples from Africa, Asia, and Latin America, showing the interconnectedness of clean water, sanitation, and agriculture, drawing upon lessons from history and economics to show a business approach to fighting poverty. Mr. Prewitt will discuss how "good charity goes wrong," presenting a solutions that last; His talk will also cover water and sanitation in post-conflict countries, and what we can expect of our partners

Polio Eradication – John Nanni

John is a member of the Middletown-Odessa-Townsend (MOT - DE) Rotary Club who transferred last year from the RC of Hamilton, NJ. John has been active in leadership roles in both clubs, serving as Club Secretary, Website Committee Chair and on both District PolioPlus Committees. Currently John is District 7630 PolioPlus Chair, a Paul Harris Fellow+3 and is a member of the Paul Harris Society. John was one of Rotary International PolioPlus representatives at the UN Special Session on Polio Eradication in 2012.

John is a polio survivor (Class of 1953), paralyzed from his neck down for 6 months just prior to the Salk Vaccine distribution, recovered fully as a young adult but now suffers from severe Post-Polio Syndrome. John has given Polio Talks to Rotary Clubs, RYLA and Interact Clubs throughout the NE USA and will update us on the status of Rotary's Polio Eradication program

Rotary Foundation and World Peace – John T. Capps, PDG

Charter President, RC of Morehead City-Noon, one of four co-organizers of CarolinasMulti-District PETS, John T. is a Business Coach and founder of Conference Cruises With a Cause. A Certified Disaster Volunteer with The Salvation Army, Boys and Girls Clubs, Meals on Wheels Driver, RYLA and Interact Clubs. He is a requested motivational, Inspirational and humorous story teller. A third generation Rotarian, John T. has attended 35 International Conventions, a GSE Team Leader and Polio National Immunization Day Volunteer for 10 years in India.

John T. Capps has been a great supporter and cheerleader for the Rotary Foundation. In this presentation, John will tell us how the Rotary Foundation Peace and Conflict resolution programs are expected to defuse crises with our trained Alumni in non-Governmental organizations and governments around the world.

Interfaith Council of Philadelphia - Rev Josh Blakesley

Founded in January 2004, the Interfaith Center of Greater Philadelphia advances mutual trust, understanding, and cooperation, in order to work together for the common good of the region. Through celebration, service, education, and action, the IC enables people of all faiths [and secular traditions] to share their deepest convictions, shape solutions to common problems, and live out their highest values and aspirations. The Center's holistic approach to learning engages the head, the heart, and the hands through teaching, dialogue, and service.

We bring together religious leaders, congregants, and youth to get to know each other as people and to learn how to value and respect the "other" while maintaining (and often strengthening) their own religious identities. Our tagline, Dare to Understand, conveys a sense of the courage required to participate and engage in interfaith work: to be bold in learning about one another, to dare to listen sincerely to the crying needs of our time, and to work together for the common good of our region.

Fighting Homelessness De Paul House – Peg Robertson

Peg Robertson is the director of Development for De Paul USA which has facilities in a number of cities in the USA and is affiliated with De Paul International headquartered in London. At 5725 Sprague Street, in the Germantown section of Philadelphia, they have a building which houses 27 formerly homeless men. These men must be between 18 and 65 years of age, homeless and free of substance use for at least three months.

At the house they receive a room, three meals a day, vocational counseling, and other assistance. They find work, save some money and in a little while (average time 7 months) they leave for their own place and are no longer homeless. In fact 80% of those graduating from the De Paul program are successfully reintegrated into society.

Ebola Crisis in West Africa – Bishop Billy Simbo

Bishop Billy is from Sierra Leone, Africa and will share his firsthand experience with the impact of this new disease while describing what our local Rotary Clubs can do to help support the eradication of this disease in our world BEFORE it spreads further to our country

How One Rotary Club Responded to Unexpected Terrorist Attack and Met the Needs of the Community – RI Rep Helen Reisler, PDG

Everyone over 7 years old can tell you what they were doing when they heard about the planes crashing into the World Trade Center. In this presentation, Helen, our President's Rep, will tell you her unique story. In 2001 Helen became the first woman President in the 92 year history of the Rotary Club of New York and was unexpectedly faced with the greatest challenge – the 9/11 terror attack on NYC. Her focused leadership kept up her club's spirit and helped to raise \$1.4 million which was efficiently disbursed to the needlest. She will discuss Rotary's role in relief efforts and her role at that time in this highly sought after presentation.

Assessing Community Needs - Mark Barnard

Mark Barnard was the 2013-14 President of the Glenside Rotary Club and led them through their Fall 2013 Community Needs Assessment bringing together numerous stakeholders from Abington and Cheltenham. Mark will provide you with information and the knowledge to guide you in assessing your community's strengths and weaknesses to help you plan, implement and evaluate effective service projects.

State Representative Mark B. Cohen

State Representative Mark B. Cohen (D Phila) has served 21 terms in the Pennsylvania state legislature and is the most senior member of the legislature. He has been involved in Pennsylvania politics since the post-Watergate era and has been involved in a vast number of issues that has affected our citizens since that time. He was 24 years old when first elected to the state house in 1974.

He is the newest member of the Rotary Club of Northeast Sunrisers, Philadelphia. He himself has been involved as a legislator from things as varied as an investigator of the three mile island nuclear accident, co-sponsored the bill which established a consumer advocate on the Public Utilities Commission, introducing a resolution opposing the war in Vietnam, providing for 75 days notice before plant closings, homeowners emergency mortgage assistance, helped enact the first whistleblower law and literally thousands of other issues.

Rotary Foundation Peace & Conflict Resolution Program

- Lt. LaMonte Adams

LaMonte Adams was named as a winner of prestigious Rotary International Peace Fellowships for 2014 in late October 2013. The Philadelphia Police Lieutenant was selected for a three month study abroad at the Rotary Peace Center at Chulalong-korn University in Bangkok, Thailand. Lt Adams will speak on his experiences as well as the Rotary Foundation Program.

Managing 1000 Volunteers in the Prison System - Loida Moreno

Loida Moreno, the Executive Director of the Volunteer Services Department of the Philadelphia Prisons System will be addressing our plenary session entitled, "Managing Thousands of Volunteers at the Philadelphia Prisons system.." Loida was recently inducted as a new member of the Rotary Club of Northeast Sunrisers Philadelphia PA. She will tell about what it is like to be a prison volunteer. Volunteers bring a wide variety of skills to the prisons. They teach reading, college courses, participate in religious programs, creative programs and even athletic programs. She will also lend some perspective to the mass incarceration of our citizens (100,000 prisoners in Pennsylvania alone), how it affects society and how it affects our safety.

Slavery and Human Trafficking – Carol Metzker

Slavery and human trafficking don't just exist "over there." They're right outside our front door. Rotarians are helping victims and survivors of slavery locally – find out how and lend a hand. Carol Metzker is a writer, frequent speaker, and author of the book, Facing the Monster: How One Person Can Fight Child Slavery. Writing assignments took her to India in 2004, where she met an 11-year-old girl rescued from slavery. The encounter resulted in her leadership of projects to aid survivors of human trafficking locally and overseas, including volunteering at Dawn's Place, a Pennsylvania residence for female survivors.


