

Each Rotary Club should decide who will be appointed the Club Communications Officer. Each Rotary Club will need a computer literate person who can be the Club Data Base administrator. This person can be the club secretary, treasurer or any other person with the computer knowledge and Rotary knowledge to act as the Rotary Club’s communications officer. More about this at a later time with the call for a training session.

Please read the article about the call for nominations for the current vacancy of District Governor for 2011-12 and also for the newly created position for the 2012-13 Rotary years on pages 4 and 11. There is a precise process that has to be followed and the Rotary Clubs need to start searching for qualified candidates they can nominate for these very im-

portant District positions. The District Nominating Committee is chaired by PDG Russ deFuria and is populated with four additional members according to the governing district resolutions. Said resolutions require that those additional four member’s names shall remain anonymous. The purpose for this is to avoid Campaigning, Canvassing and Electioneering which is strictly prohibited in Rotary.

The GSE committee is in the process of interviewing team leaders and will interview and pick team members by the end of November. Please continue looking for qualified team members for this exciting opportunity.

# Keep Rotary Fun!

## Some thoughts on membership retention and reflection

Based on Rotary International statistics, the three top reasons that people leave Rotary in years 1-2, 3-5, 5-7 is "Failure to meet Fellowship Expectations."

As one of many ideas to assist your Club retain membership, please consider planning something that is **FUN** during every quarter. If a person's "best friends" are in Rotary, the person will make Rotary a priority.

### Here are five suggestions to consider:

- Increase the number of planned events in your club that include family members. Invite family members to a meeting. Bring your children and grandchildren to Rotary from time to time. There is a club in District 7450, of which I am aware, that once a year plans an annual special program that is "child friendly" and well supported by the Club's Rotarians.
- Increase the number of fellowship activities. Some clubs have "Dutch Treat" socials at predetermined times. Everyone won't come but the people that do form lasting friendships. Extend a special invitation to those members who hesitate to offer their service in other Rotary activities.
- Consider forming "small groups" within your Club. Perhaps a quarterly Pot Luck dinner for Rotarian families interested in community service, or a group comprised of members under 40, who work to identify potential younger members, etc.
- Ask your Club members to suggest activities that they feel would be "fun" for Club members. E.g. Group trip to the theater, etc – split

the cost among participants. (People will pay for fun.)

- Appoint someone to call anyone in the club who missed twice without making up. This one act of caring will literally help turn your retention numbers around. *People need to know that they are missed and someone notices.*

Most importantly, adopt a culture in your Club that is pro-growth. We do not have one single Rotarian whom the whole Club did not vote to include. Somewhere, sometime, your Club made that person feel special. Leaders who are encouraged become better leaders. People, who feel that they matter, stay. Sometimes a call from the Club's president can make all the difference.

Stretch your wings, try something new. A strong Rotary family can change the world. Our goal is to finish this young Rotary year stronger than we were when we started.

## Call for nominees for 2011-12, 2012-13 DGs

District Governor Al Marland has issued a call for nominees for the District Governor for the years 2011-12 and 2012-13 as a result of the of the “unfortunate resignation” of Paul Woodruff, who was selected the DG for 2011-12.

PDG Russ deFuria chairs the 2009-10 District Nominating Committee. Four more will be appointed and according to the District Resolutions, they shall remain anonymous until the outcome of their deliberations has been announced. In addition to PDG deFuria, there will be another PDG on the committee along with three District Rotarians in good standing who are past presidents of their Rotary Club.

According to the RI By Laws section 13.020.2, “The Nominating Committee for Governor shall be charged with the duty to seek out and propose the best available candidate for Governor-Nominee. Section 13.020.4 also requires that “the Governor shall invite the Clubs to submit their suggestions for nominations for Governor”... such suggestions shall be considered by the Nominating Committee so long as they reach the committee by the date established by the Governor. The announcement shall be made to the Clubs in the District at least two months before such suggestions must reach the Nominating Committee. The suggestions shall be submitted in the form of a resolution adopted at a regular meeting of the Club naming the suggested candidate. The resolution shall be certified by the Club secretary. A Club may suggest only one of its members as a candidate for Governor-Nominee.”

DG Marland points out, “PDG Russ and myself will work on appointing the full committee soon and the process will begin to fill both appointments. The call to all Clubs in the District went out September 15th to start the process as defined by their Club presidents to nominate a candidate for those positions through the process of a Club resolution being certified in an affidavit by the Club secretary to nominate a District Rotarian that fits all the qualifications described in the Manual of Procedures.”

Nominations for the two Governor positions are due to DG Marland by November 15, and can be submitted by US Mail, fax or email. The committee will interview candidates by the end of November. DG Marland says, “Hopefully, we will be able to announce the appointees by the beginning of December, 2009. “

### **15.070:** Qualifications of a Governor-nominee.

Unless specifically excused by the board, no person shall be selected as nominee for Governor unless the Rotarian has the following qualifications at the time of selection.

**15.070.1:** Rotarian in Good Standing. The Rotarian must be a member in good standing of a functioning Club in the District.

**15.070.2:** Rotarian Maintaining Full Qualifications of Membership. The Rotarian must have full qualifications for such membership in the strict application of the provisions there for, and the integrity of the Rotarian’s classification must be without question.

**15.070.3:** Rotarian’s Qualification as Past President of Club. The Rotarian must have served as president

of a Club for a full term or be a charter president of a Club having served the full term from the date of charter to 30 June, provided that this period is at least six months.

**15.070.4:** Rotarian’s Ability to Fulfill Duties of Governor. The Rotarian must demonstrate willingness, commitment, and ability, physically and otherwise, to fulfill the duties and responsibilities of the office of Governor as provided in section 15.090.

**15.070.5:** Rotarian’s Certification of Qualifications. The Rotarian must demonstrate knowledge of the qualifications, duties, and responsibilities of Governor as prescribed in the bylaws and submit to RI, through its general secretary, a signed statement that the Rotarian understands clearly such qualifications, duties, and responsibilities. Such statement shall also confirm that the Rotarian is qualified for the office of Governor

**15.090.** Duties of a Governor.. The governor is the officer of RI in the District, functioning under the general control and supervision of the board. The Governor is charged with the duty of furthering the Object of Rotary by providing leadership and supervision of the Clubs in the District. The Governor should work with District and Club leaders to encourage participation in a District leadership plan as may be developed by the board. The Governor shall provide inspiration and motivation to the Clubs in the District. The Governor shall also ensure continuity within the District by working with past, current, and incoming District leaders in fostering effective Clubs. The Governor shall be responsible for the following activities in the District: (a) Organizing new Clubs; (b) strengthening existing Clubs; (c) promoting membership growth by working with District leaders and Club presidents to establish realistic membership goals for each club; (d) supporting The Rotary Foundation with respect to program participation and financial contributions; (e) promoting cordial relations among the Clubs and between the Clubs and RI; (f) planning for and presiding at the District Conference and assisting the Governor-Elect in the planning and preparation for the presidents-elect training seminar and the District Assembly; (g) providing for an official visit, meeting individually or in multi-Club meetings conducted throughout the year, to take place at a time that maximizes the Governor’s presence for the purpose of focusing attention on important Rotary issues; providing special attention to weak and struggling Clubs; motivating Rotarians to participate in service activities; and personally recognizing the outstanding contributions of Rotarians in the District; (h) Issuing a monthly letter to each Club president and secretary in the District; (I) Reporting promptly to RI as may be required by the president or the board;; (j) Supplying the Governor-Elect, prior to the International Assembly, full information as to the condition of Clubs with recommended action for strengthening Clubs. (k) Assuring that District nominations and elections are conducted in accordance with the RI constitution, these bylaws, and the established policies of RI;

**Robert Nelson of Audubon**

**Another Reason to END POLIO NOW**

For Nelson Robert, polio is more than a virus contracted by people in faraway places. It is part of his personal history. The quality assurance manager at Globus Medical in Audubon, survived the disease but he is still affected daily by its affect.

One day 41 years ago, his mother returned home from her job as a schoolteacher to find Nelson in bed and running a high fever. She lifted him out of bed and discovered that the one-year-old who had been walking and running just hours before was unable to stand. Very frightened, she whisked Nelson to the doctor who diagnosed the boy's case as polio. "Even though my dad worked in a hospital, we weren't aware of the vaccine," said Nelson.

Although the polio vaccine had been developed and was in use in the United States in the 1960s, it was barely known in Chennai, India, where Nelson, his parents and four siblings lived at that time. Nelson survived polio, which can be fatal, but it left his right leg partially paralyzed. Polio changed many aspects of Nelson's life. Experiences such as child-

hood sports, accessibility to buildings and the way Nelson drives a car have differed from those of the people around him.

As a boy, "I wished I could play cricket the same way others played," Nelson recounted. "I could still bat the ball, but someone would run for me." Traveling was—and still can be—a challenge when transportation and facilities are not designed for people with one strong leg and one weak one. "My car is equipped with a special pedal so I can operate the accelerator with my left leg," he said.

The virus did not affect his education, however. According to Nelson, his parents were hard workers and they ensured that he was able to go to school. He earned two undergraduate degrees in chemistry and engineering, and later earned an MBA. He works at Globus Medical in Audubon and his family is active in the local community.

Nelson Roberts understands why the campaign to END POLIO NOW is imperative. For some children, polio "can cause a lifetime of suffering," he said.

## District 7450 welcomes nine exchange students

Schools are open and for 15 students in District 7450, this will be a very different year. We have six of our own students outbound in Brazil, France, Germany and Thailand.

We also have nine inbound students. They all changed places in late August, and in our District, we held orientation for our Inbounds to help them get started with fitting into new schools, new families and a new culture.

They are an interesting group – great language skills, diverse interests and backgrounds. They will be attending local high schools as juniors or seniors and taking regular classes. We have planned activities with them at least once a month throughout the year. Trips to DC and NYC, Christmas at Longwood, a ski trip and RYLA are just a few. We look forward to a great year with them!

Do you know anyone who might be interesting in this program either as a student,

or as a host family? The Exchange Program is available to high school students of both Rotarians and non-Rotarians. The long-term program is one in which the student attends school in his or her host country, lives with a host family throughout the year and experiences the language and culture of that country, on a first-hand basis during the year.

September-November are the months where we are recruiting for exchange students to participate in the long-term program for the 2010-2011 school year. We have spoken with a few students and have applications in the works, but we really need many more. What we're looking for this year is for more

clubs to participate in this program. This year only one of the 55 clubs in the District is hosting or sending students, and we had slots for almost twice as many students. Ask any student who has participated and they will tell you that this is a life-changing program.

If you would like to have someone from the Student Exchange Committee or one of our students in the program visit your club or local school to discuss the Youth Exchange, please let me know. There is also a short-term program that is available and we will take applications in October through April for this program.

The short-term program is a one-on-one program where matches are made and the two students spend four to six weeks in the District with our student's family and then four to six weeks abroad in the other student's home. This is great program for students who are looking for an

international experience but are not sure they can or want to commit to a full-year program. It does require that the family here host a foreign student. Students in both programs must be between the ages of 15 ½ and 18 ½ at departure.

## Information Minute for Vocational Service Month

### Herbert Taylor and the FOUR-WAY TEST

When the Great Depression began at the end of 1929, Herbert Taylor was an executive vice-president at Chicago's giant Jewel Tea Company. He earned \$33,000 a year and was in line for the presidency.

In 1930, a local bank asked Jewel Tea to donate one-half of Taylor's time to an attempt to save the Club Aluminum company. Club manufactured and distributed cookware. Club's debt exceeded total assets by \$400,000 and there were several lawsuits.

Taylor took the job. He soon discovered that the problems at Club Aluminum required his full time attention if they were to be solved. Jewel's president urged him to give up and return to Jewel full time, eventually becoming Jewel's president. But Taylor thought he could do more good by saving the jobs of the Club Aluminum employees.

So putting service above self, he resigned from Jewel and assumed the job of Club Aluminum's president. He cut his salary from \$33,000 to \$6,000. He also provided short-term operating capital of \$6,100 for the firm by borrowing against his Jewel stock and his home equity.

Taylor then made numerous changes which eventually returned the company to profitability. But in his mind, the most important change he made was that of raising morale and performance by creating a new culture of high ethical standards. Club Aluminum became a company known for its honesty, fairness and commitment to doing business in ways that benefited all stakeholders—customers, employees, supplier and stockholder.

To change the culture, Taylor needed a company code of ethics which was simple and effective. It took him some time to find what he needed. But the answer eventually came to him unexpectedly while he was sitting at

his desk and praying. That answer was the "Four-Way Test." The year was 1932.

Taylor wanted to be sure that the test would be consistent with the beliefs of all workers. So he conferred with employees representing four different faiths and found that the test did, indeed, appear to represent universal values.

The company soon returned to profitability. The profits made it possible to pay off the debt by 1937 and over the next 15 years, stockholders received over one million dollars in dividends.

In 1942, Taylor told the story of the Four-Way Test at a Rotary meeting. Several Rotarians asked if they could use it. A member of the RI board asked if Rotary International could use it and permission was granted. In 1943 the RI board of directors officially adopted the Four-Way Test.

When Herbert Taylor became president of Rotary International in 1954 he presented the Four-Way Test copyright to Rotary.

By Rotary's 100th anniversary, the Four-Way Test was being used in 100 languages all over the world.

Morals of this story: The Four-Way Test works, Service Above Self is a winning business strategy, They Profit Most Who Serve the Best, and today's Rotarians are the trustees of Herbert Taylor's gift of the Four-Way Test copyright with all of the duties that trusteeship implies.

# Rules for nominating, electing DG-Nominee

## *(CONTINUED FROM PAGE FOUR)*

(k) Assuring that District nominations and elections are conducted in accordance with the RI constitution, these by-laws, and the established policies of RI; (l) Inquiring on a regular basis about the activities of Rotarian organizations operating in the District (Friendship Exchanges, inter-country committees, Global Networking Groups, etc.); (m) Transferring continuing District files to the Governor-Elect; and (n) Performing such other duties as are inherent as the officer of RI.

### **Rotary Code of Policies**

**17.040.** District-Level Elections. Districts are encouraged to use the Nominating Committee system for all District elections (with a ballot-by-mail in the event of a challenge to the selection of the Nominating Committee) provided however, that Nominating Committees need not be used to select the members of Nominating Committees.

**17.040.1.** Guidelines for District-Level Elections : The Governor shall send the "Guidelines for Candidates for Elective Position in RI," as adopted by the RI Board, as well as the following list of election guidelines to all Clubs at the time of the official call for nominations: Rotarians and election candidates shall: 1. Learn and follow both the spirit and the letter of RI's election guidelines; 2. Consult with knowledgeable Rotarians if you have any concerns about a current assignment or a new assignment if it may give an appearance of campaigning; 3. Not undertake personal initiatives to gain visibility, personal recognition, or favor; 4. Not respond in kind to another candidate's improper activities; 5. Not communicate with or visit Clubs involved in the applicable election except to fulfill necessary functions.

**19.030.1.** Selection: The selection by the Clubs of a Governor-Nominee should be conducted in a dignified, responsible manner in harmony with the principles of Rotary. Districts should seek out and nominate for the office of District Governor the best qualified person. District Nominating Committees are encouraged to interview all candidates for Governor, whether they are suggested by Clubs or by the Nominating Committee. Each interview of Governor-Nominee candidates should satisfy the following minimum needs: Verify that each candidate meets the formal requirements for nomination, in accordance with RI Bylaws sections **15.070.** and **15.080;** Clarify the specific duties that a Governor requires, including knowledge, experience, time, and fiscal resources; Allow an overall summary of each candidate's qualifications and suitability; enable each candidate to reveal her or his intentions and ambitions.


**19.030.2.** Selection of Governor-Nominee through Ballot-by-Mail Procedure: Information to be included in the biographical data to accompany ballots-by-mail for election of the governor shall be as follows: Name of candidate; name and location of Rotary Club; number of years a Rotarian; classification or former classification; name of firm or former firm; position in firm or former firm; meetings attended in last five years; position's) and/or assignment's) in Rotary (elective or appointed); former position's) and/ or assign-

ment's) (elective or appointed); Special Rotary services and/or particular Rotary activities in which candidate has been engaged, i.e. what candidate has done to advance Rotary. Rotary Code of Policies 96 June 2008; Most significant honors or achievements in business and professional activities; Most significant honors or achievements in civic and public service activities.

**26.100.5.** Rules Regarding Campaigning, Canvassing and Electioneering: It is a fundamental principle in Rotary that the best qualified candidate should be selected for service in Rotary's elective offices. Therefore, any effort to influence the selection process in a positive or negative manner by campaigning, canvassing, electioneering or otherwise is prohibited under the RI Bylaws. Rotary Code of Policies 135 June 2008. The following rules shall be followed concerning campaigning, canvassing and electioneering for any Rotarian considering election to the office of president, director, Governor, or representative to the Council on Legislation, or the Nominating Committee for any such office. These rules are designed to ensure that the best qualified candidate is selected office: Rotarians should at all times conform to the prohibitions of the RI Bylaws concerning campaigning, canvassing or electioneering. All Rotarians should observe both the letter and the spirit of the bylaws and refrain from any activity whose purpose or effect is to influence others by promoting or soliciting support for a candidate's or another Rotarian's candidacy. Such activity is repugnant to the spirit of the bylaws and the principles of Rotary and will be grounds for disqualification of a candidate; Campaigning, canvassing or electioneering is any action seeking to promote, attack, support, or oppose a candidate, either directly or indirectly, in any medium, including, but not limited to, any action seeking votes, requesting support in a forthcoming election, distribution of literature or promotional materials or other overt actions intended to promote one's candidacy for an elected Rotary office; The periods of candidacy for elective office begin when individual Rotarians begin to give serious consideration to submitting their names for a position covered by the RI rules for nominations and elections. Commencing at that time, candidates should be particularly careful to avoid any actions designed to publicize their names or achievements, to call attention to the applicable nominations or elections, or to give candidates an unfair advantage over other candidates for the same position; The normal performance of duly-assigned Rotary activities would not be considered to be a violation of the policies related to campaigning, canvassing or electioneering. Should a candidate become aware of any campaigning or electioneering activities which are undertaken on the candidate's behalf, the candidate shall immediately and in writing express disapproval to all concerned and instruct them to terminate such activity. Contacting Clubs to inform them to request their concurrence for a proposed challenge or election complaint is not prohibited provided that such contact is limited to the exchange of factual information.
